APPLICATIONS INSTRUCTIONS

All forms must be completed and signed before mailing to the Grand Secretary and **postmarked no later than April 15th**.

Questions can be referred to the Scholarship Chairman for the year applying.

APPLICATION MUST INCLUDE:

1. The application page with the 6 points of interest. Typed separately one page limit.
2. The resume page typed including the 10 reference points. One page limit.
3. The essay entitled "What Job's Daughters Means to Me", typed and including the 4 areas of interest and limited to one page.
4. Parent or Legal Guardian's Statement.

These four pages may be mailed together.

To be sent to the Grand Secretary separately

1. Information from the school or college typed page. The appropriate school should complete the form and mail or email it directly to the Grand Secretary. Suggestion – provide a stamped envelope addressed to the Grand Secretary.
2. Bethel Guardian Council typed information (6 points) and letter. The SEAL: of the Bethel should be placed in the designated area. Attached to the form should be a letter from one member of the Executive Bethel Guardian Council, who is not a parent of the applicant. These should be mailed directly to the Grand Guardian Secretary.

6. Please list our hobbies or special interests.

Resume Page – Limit 1 page

Please include in your resume the following information and submit with the application.

1. Your full name and address and date.
2. Your parents or legal guardian's full name and address.
3. The name and town of the school you just completed.
4. Number of students in your graduating class if just graduated from high school.
5. Your accumulative grade average.
6. School activities and honors.
7. What vocation or major do you plan to enter and how do you plan to use your education?
8. Name of the institution you plan to attend with address and date you plan to start.
9. Class level you expect to enter in the fall. *Freshman, Sophomore, Junior, Senior*
10. A short statement how this scholarship would help your financial need toward a higher education.

Essay: "What Job's Daughters Means to Me"

Please submit a one-page essay with the above title.

1. Your offices held in Job's Daughters.
2. Your favorite office in Job's Daughters and why?
