Names of those receiving a majority recommendation shall be listed on the following form, which shall be forwarded to the Vice Supreme Guardian at least eighty (80) days prior to the Supreme Session or to the Vice Grand Guardian at least twenty (20) days prior to the Grand Session.

- a member of an organization basing its membership requirement on Masonic relationship or
- a Past Bethel Guardian or
- a Majority Member of JDI
- a mother, grandmother, or guardian of a Daughter in good standing.



4. Ballots shall be taken on Form 221 at a meeting held no later than May 1st, 2026.




